In June this year the SECRA committee took out public liability insurance as a requirement for applying for the Green Adelaide grant to plant more trees and increase biodiversity in Victoria Park. Public liability insurance also allows SECRA to conduct such things as members' event, guided walks.

After much discussion the committee also took out Not-for-Profit

Protector/Association Liability insurance to protect committee members.

This had been suggested by a previous committee member who felt it necessary in litigious times.

Elizabeth Rushbrook, Doug McEvoy, Anne Ballard, Peter Lumb and Mark Gishen were elected unopposed because there were five nominations for six positions.

Once a new committee has been formed the committee will then decide who will take on the positions of Chairperson, Secretary, Treasurer and Membership Secretary.

It's the committee's wish/intention to draw on members' ideas and expertise to help determine what projects and community events SECRA might initiate in 2023, and learn how members could involve themselves in these projects. The committee intends to survey the membership re their specific interests and willingness to commit time to potential projects.
