Public consultation 1: Help shape the future of the Adelaide Park Lands

Kadaltilla or APLA as it used to be known is the principal advisory body to the City of Adelaide and State Government on the Park Lands. A key responsibility of Kadaltilla is the development and review of the Adelaide Park Lands Management Strategy (APLMS). The APLMS is reviewed every five years, and Kadaltilla is embarking on an update of the APLMS in 2022/23.

Therefore, during August Council is seeking groups and individuals to:

- Contribute to a compelling vision for the Park Lands
- Imagine and share ideas on Park Land challenges and opportunities
- Nominate project ideas and send them to council by 5.00pm Friday, 2 September 2022.

Public consultation 3: the Council would like your views on the Installation of 'green infrastructure' at the corner of Halifax and Hutt St.

They have installed two 'green' structures at the corner of Halifax Street and Hutt Street, which contributes to an objective in the **Draft Hutt Street Master Plan: Enhance amenity, green spaces and connection to the Park Lands**. The green structures installed are a lightweight tree canopy-shaped trellis in a round planter base. They are 3m tall, and 5m wide at the top, and have been planted with chocolate vine (*Akebia quinata*), which should fill each trellis over the next 2 years.

Public Forum -Save the date

Above and Below Ground Transport: planning for a bigger and more vibrant Adelaide

Thursday September 8th 5.30-7.30pm at the Minor Works Building Community Centre, 22 Stamford Ct, Adelaide SA 5000

In a very timely move the Transport Action Network is joining with SECRA and the South West City Community Association to hold this **free** business owners’ and residents’ forum.

It is a great opportunity to hear from transport experts and feed in your ideas on how Adelaide’s transport systems can be redesigned to

- Improve access to Adelaide’s key business, cultural and recreational precincts
- Increase the efficiency and safety of public and active transport
- Reduce road traffic congestion, CO2 emissions and pollution

Several initiatives will be discussed by leaders in transport design, including an underground city rail loop that is linked to existing northern and southern train services; dedicated bus streets and separate paths for walkers, bikes/ scooters and cars; and lowering road speed limits.

Speakers are:

- Tom Wilson - Public Transport Planner, Public Transport Historian, Former CE of public transport in SA
- Dominic Mugavin - President, People for Public Transport
- Dr Helen Donovan - Adelaide City Councillor and CE of Walking SA who foreground economic issues
- Dr Donna Ferretti - Urban Planner, Life Fellow of Planning Institute of Australia

Expert panel to review SA's planning system

The State Government has appointed a four-person industry panel to review South Australia's planning legislation, parts of the Planning and Design Code and the e-planning system.

The panel will be led by planning consultant John Stimson and will include

- Cate Hart, the president of the Planning Institute of Australia (SA) and a senior public servant in the Department of Environment and Water,
- Andrew McKeegan, the executive director of transport property in the Victorian Department of Transport and a former senior South Australian planning bureaucrat, and
- Lisa Teburea, the executive group manager planning and urban policy with the ACT Government.

The Government, which foreshadowed the move ahead of the state election, said the aim of the review was to "encourage a more liveable, competitive, and sustainable long-term growth strategy for Greater Adelaide and our regions".

Planning Minister Nick Champion said the review's scope would cover:

- The Planning, Development and Infrastructure Act 2016.
- The Planning and Design Code (and related instruments) "as it relates to infill policy, trees, character, heritage and car parking".
- The e-planning system "with a view to ensuring that it is delivering an efficient and user-friendly process and platform".
- The PlanSA Website "with a view to ensuring its usability and access to information by the community".

The panel would provide recommendations to be considered by the Government next year.
